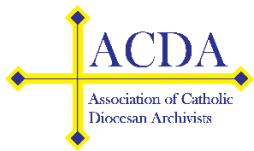

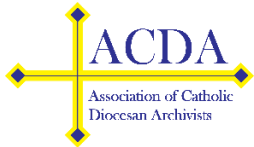

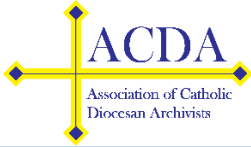

### Keynote Address by Dr. Shannen Dee Williams

*Still Mining the Forgotten: Black Catholic Women and Girls and the Challenges of the Archives with*

Dr. Shannen Dee Williams is Associate Professor of History at the University of Dayton. She is the author of *Subversive Habits: Black Catholic Nuns in the Long African American Freedom Struggle* (Duke University Press, 2022), which was named a top five book published in religion by Publishers' Weekly in 2022. *Subversive Habits* also received the 2022 Letitia Woods Brown Award for Best Book in African American Women's History from the Association of Black Women Historians and the 2023 Wesley-Logan Prize for Outstanding Book in African Diaspora History from the American Historical Association and the Association for the Study of African American Life and History.

A Distinguished Lecturer for the Organization of American Historians, Dr. Williams authored the award-winning column, "The Griot's Cross," published by the Catholic News Service from 2020 to 2022.

### Archives & Records Management 101

Presenter: Dr. Emilie Gagnet Leumas, PhD (EGL Consultants)

**NOTE: This full-day workshop is divided into 4 sessions. It runs concurrently with Track 2 sessions.**

This course provides a survey of canon laws, practices, and principals that diocesan archivists and records managers apply, as well as issues that they confront while managing diocesan records. We will discuss the policies, procedures, retention schedules, disposition, finding aids, and recordkeeping standards. This course is designed for those that are new to their position, have limited experience in archives and records management, or those who have been charged with oversight of the archives and records management program.

***Caring for Architectural Records: A Collaborative Approach***

Architectural records offer invaluable historical insights into the design and construction of our built environment. Their active management and thoughtful preservation are crucial for research. This session provides holistic strategies for managing architectural collections, from working with records creators to arrangement and description to discovery and access. Participants will gain practical knowledge to appraise, manage, and care for architectural records from acquisition to access. By collaborating across skill sets, archivists can ensure architectural records are preserved and made available to reveal an institution's infrastructure and design over time. Come learn how to manage these invaluable historical records thoughtfully. The discussion will cover original order, logical organization, crafting DACS-compliant finding aids, and providing access. Promoting collections to target research communities will also be addressed.

***Pennies in the Cup: Tips, Tricks, and Strategies for Handling Interpersonal Situations***

Presenter: Emily Ahlin (Cleveland)

Whether it's a person who wants their sacramental record **right now** and doesn't understand why you haven't responded to the voicemail they left five minutes ago, a challenging coworker who still doesn't understand what an archive is, or trying to explain to a researcher why they can't just open whatever boxes they feel like opening in your stacks, archivists regularly encounter challenging interpersonal situations. Handling them is seldom easy, but it can be do-able! This interactive workshop, informed by years of customer service experience, will cover good boundaries and empathy-driven de-escalation strategies to give you the tools you need to better handle challenging interpersonal situations in person, on the phone, and through email. Participants will also have time to practice example strategies and brainstorm new ones with colleagues. At the end, you'll feel more confident and better prepared to handle the next difficult person who walks through your door, even if they (or you) are having a bad day!

### ***An Unexpected Journey: Moving the Records of Religious Institutes to Diocesan Archives***

As more and more religious institutes are facing completion, the question of what to do with their archives has been an issue of concern. Options available include the creation of a collaborative archives program and depositing in a university archives. Another is transfer to a diocesan archives. This session will feature three diocesan archivists who have the archives of religious institutes in their holdings and will speak on their experiences of creating a program that meets the needs of all parties and discuss the challenges and opportunities this option presents.

### ***Outside the Fence: Identifying Remains in Plantation Cemeteries***

Presenters: Amy Simon (Baton Rouge), Sarah Waits (New Orleans)

For much of its early history, plantations drove the economy of Louisiana. From the mouth of the Mississippi River to the border with Arkansas, cotton, sugarcane, and rice plantations produced marketable goods using unpaid chattel slave labor. Many Catholic enslavers in Louisiana baptized the enslaved people who worked on their plantations, and those records are in the archives of Louisiana dioceses. Finding funeral and burial records for enslaved people on plantations is more difficult. However, records for people, both enslaved and free, buried outside of official church cemeteries abound within the sacramental records in rural Plaquemines and St. John the Baptist parishes. Many of those plantation cemeteries, though, are completely unrecognizable, with no headstones, markers, or information about those interred within. In many cases, petrochemical corporations own the land of former plantations, and access to plantation burial grounds is all but impossible.

This conference panel will cover a project currently underway in the Archdiocese of New Orleans to catalog each burial that occurred outside the church cemetery at St. Thomas in Pointe-a-la-Hache, and will review deliverables, discuss engagement with descendant communities, and provide tips and suggestions for other Catholic archives that would like to embark on a similar project to assist vulnerable communities.

***CROSS Update and Best Practices Guide***

CROSS - Catholic Religious Organizations Studying Slavery - was established in 2021 by 12 men and women representing nine dioceses and three religious organizations, convened to study the records of enslaved peoples in Catholic archives.

In this session, Dr. Stephanie S.T. Jacobe and Thomas Lester will provide a brief update on the inaugural CROSS conference which took place in St. Louis from October 30-31, 2023, and how the organization is hoping to develop over the coming years. Additionally, they will introduce the CROSS Best Practices Guide and lead attendees through small group discussions on how CROSS and the Best Practices Guide can best serve them and their respective institutions.

***What We Have Done, What We Have Failed To Do: Archives and the Diocesan Merger Process***

Presenters: Eric Fair (St. Louis), Dennis Wodzinski (Pittsburgh)

The last five years have seen tumultuous change and realignment in diocesan organization and operations. In response to a declining Catholic population and an aging priesthood, many dioceses have chosen to undertake significant diocesan-wide mergers of parishes and parochial schools.

This presentation will provide case studies from the Archdiocese of St. Louis and the Diocese of Pittsburgh, regarding large-scale parish and school mergers. Most importantly, these case studies will examine in detail the implications for diocesan archives and their operations. Eric will focus on the role the St. Louis archives plays in support of diocesan school closures, and Dennis will discuss his experience in assisting a diocesan-wide, parish reorganization program. Both archives have experience with large-scale parish and school restructuring efforts. These case studies will provide insight into what worked well, and what has caused archival consternation.

***Copyright Legal Issues in Archival Records***

Presenter: Menzi L. Behrnd-Klodt, J.D., C.A. (Klodt &amp; Associates)

All archivists benefit from a basic knowledge of copyright law and principles, both in conducting their own work and when helping researchers. But questions and uncertainty about the applicability of copyright law and our risks in collecting, using, digitizing, and providing access to historical records, books, and photos unnecessarily may worry and confuse archivists. This presentation (and a supplied supplemental pre-reading) focus on practical copyright issues and tools to help participants develop their own knowledge and build a framework to better manage copyrighted materials without concern. Participants will learn about the foundations and rationale of copyright, what is (and is not) protected by copyright, the exclusive rights of copyright owners, who is a copyright owner, copyright duration, the public domain, important copyright exemptions, and more. Our focus will be analyzing and managing risks to help archivists make sound decisions enabling archival work to proceed without fear.

More of the day-to-day reality of a Chancellor, Records Manager, and/or Archivist is dealing with various lawsuits against the diocese. This session will provide dual perspectives from an archivist/records manager with outside counsel and from an in-house diocesan attorney on the entire lifecycle of a lawsuit from litigation holds to the production process to the dreaded deposition. The goal of the session will be to provide you with some guidance on how to manage the potentially unexpected (and at times very time-sensitive) workload that litigation brings as well as how to communicate effectively with your legal counsel. Where appropriate, examples of template documents will be provided. The hope is that a robust discussion/Q&A will offer some context and examples of what has or has not worked for other attendees.
